

FTA already in force

- Trade, Development and Co-operation
 Agreement with South Africa since 2000
 → liberalisation schedule completed in 2012
- FTA with Mexico since October 2000 → possible upgrade
- FTA with Chile since February 2003
- FTA with South Korea since 1 July 2011 (first new generation FTA)







FTA finished but not yet entered into force

- FTA Singapore → concluded on December 2012 and into force in spring 2013
- Peru and Colombia → Provisional application in January 2013
- Central America → Costa Rica, El Salvador, Guatemala, Honduras, Nicaragua and Panama
- Ukraine → concluded in December 2011 and signature once political conditions are met
- ACP → Cote d'Ivoire, Cameroon, Southern African Development Community, Ghana and Eastern African Community







On-going negotiations

- Comprehensive Economic and Trade Agreement with Canada → negociations started in May 2009 and are in their final steps
- FTA with lands of ASEAN → Malaysia since May 2010, Vietnam since June 2012 and launch with Thailand in March 2013but the objective is a regional agreement
- Eastern Neighbourhood → Georgia, Armenia and Moldova. The objective to conclude is the Summit in November 2013







On-going negotiations

- India → negotiations started in 2007. Negotiations focus on hard core issues
- Mercosur → re-launch in May 2010. Next step eind of 2013 with the exchange of offers
- ACP → based on Cotonou Agreement. EPA are ongoing with many regions





Forthcoming negotiations

- Transatlantic Trade and Investment
 Partnership between with United States
 → following the conclusions of the HLWG (mandate on negotiation)
- Mandate to open trade negotiations with Japan → November 2012 MS mandated EC to open FTA negotiations and launch during the Summit Japan-EU of 25 March
- Southern Mediterranean (Egypt, Jordan, Morocco, Tunisia → In December 2011, Council adopted directives negociations and in November 2012, Council agreed to launch negotiations with Morocco
